

Official Giveaway Rules & Regulations

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who are 18+ and located in the United States.
2. Agreement to Rules: By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of Camp MasterChef as final and binding as it relates to the content of this Campaign.
3. Campaign Period: Entries will be accepted online starting 4/20/18 on and ending on 6/15/18 @ 11:59PM ET. All online entries must be received by 6/15/18 @ 11:59PM ET.
4. How to Enter: The Campaign must be entered by submitting an entry using the online form provided at [URL HERE].
